H U A R A Z

Huaraz is located 420 km. from Lima, only six hours by car, with first-class bus connections (with both day and night departures). The route to Huaraz leaves the Pan-American Highway at Paramonga (Km. 210 north of Lima), and climbs to Conococha—the highest point at 4,080 meters and gateway to the Callejón de Huaylas—before descending to Huaraz.

Located at 3,000 meters above sea level, Huaraz is the capital of the Chavín Region, with a population of approximately 160,000 people. The city has been completely reconstructed since the 1970 earthquake. It is part of the tourism center and is the major point of departure for visits to Huascarán National Park, Chavín de Huántar, the Puya Raimondi/Pastoruri Glacier, Wilcaguaín, as well as climbing expeditions and hikes in the Cordillera Blanca and the Cordillera Huayhuash. Major mining companies (gold and copper) are also based in Huaraz.
